#### **Requirements for Year of Reign**

- ◆ I understand that as part of the Peach Court, I will be provided a dress, sash, and crown to wear at events; in addition, other apparel may be provided (such as a t-shirt or vest). Outside of these, any other miscellaneous out-of-pocket Court expenses would be my responsibility. Estimated expenses for the upcoming Court will be discussed during the Information meeting on May 31, 2024.
- ◆ **I understand ANY and ALL purchases must be approved by the Stonewall Chamber of Commerce.**
- ◆ I understand that I may be expected to assist with set up for any required event.
- ◆ **I understand that if I miss required community events without consent of the SCC Board of Directors, I will be asked to resign and will forfeit my title, crown, and scholarship.**
- ◆ I agree to maintain school attendance during the year of reign and maintain a minimum grade average of 75. I understand that if I drop out of school, I will be asked to resign and forfeit my title, crown, and scholarship. I further understand that I must submit a request for home schooling for consideration and vote by the Board of Directors of the Stonewall Chamber of Commerce.
- ◆ I agree not to enter any contests or activities that will interfere with my year of reign (i.e., Fair Queen, Farm Bureau Court, etc.)
- ◆ I understand and am aware of the events for my 2024-2025 reign, (See attached spreadsheet) and agree that if I miss more than the nine required events, my scholarship will be deducted or not be awarded.
- ◆ I agree to represent the Stonewall Chamber of Commerce and the peach industry during my year of reign and understand that as part of this responsibility, the following will not be tolerated:
  - ◆ Pregnancy or marriage
  - ◆ Criminal charges – misdemeanor or felony (excluding traffic violations),
